# Bank Retirees - Why "NO" action on pension updation even after 30 years?

## **Fatal accident on Dholera-Bhavnagar highway**

### 4 killed in collision between two cars; 9 people lost their lives in 13 days near Sandhida



Dholera A horrific accident took place today near Sandhida on the Dholera-Bhavnagar highway. Four people lost their lives in an accident between a Hyundai Verna and a Maruti S-Cross car

On May 12, 13 days ago, a horrific accident took place on the Dholera-Bhavnagar highway. In which 5 people including 3 brothers and a son from Ahmedabad died when two cars collided. After that, today (25/05) another horrific accident took place. In which a total of 4 people died. In the last 13 days, a total of 9 people have lost their lives in two

The accident was so horrific that both the vehicles were badly damaged. One person sustained serious injuries in the accident and has been rushed to a hospital in Bhavnagar for immediate treatment.

As soon as the incident was reported, the Dholera police and 108 ambulance team immediately reached the spot. The police have registered a case of accident and are conducting further investigation. Frequent accidents on this road have created a wave of concern among the locals.

### Fraud on the pretext of selling a flat

Ahmedabad

A young man from Ahmedabad had given a total of Rs 35 lakh to the owner of the flat in Sola, as he wanted to sell his flat, through bank and cash. The owner of the flat gave it to the young man in a forged document. After that, a deal was made to pay the remaining amount in 12 months and get the flat deed. When the young man went to the owner of the flat to get the remaining money, the owner of the flat had made an forged document in the name of his parents. The young man did not even return the Rs 35 lakh he had given. Therefore, the young man has filed a owner of the flat at Chandkheda police station.

Vanit Patel, a 34-year-old man living in Chandkheda, works in real estate. About a year ago, Vanit got information from his friend that his flat in Blossom Luxurious in Sola was to be

sold to a person named Soham Thakkar. So, when Vanit talked to Soham, he decided to sell the flat for Rs 65 lakh. Vanit paid Soham Rs 35 lakh. Soham had also given Vanit a bank account and had talked about paying the remaining amount of Rs 39 lakh within 12 months and getting the flat deed. In August 2024, when Vanit had the remaining money, he informed Soham.

When a complaint of fraud was filed due to the cheque bouncing, Soham did not answer the phone. After which, when Vanit checked online properties, Soham had given this flat to her parents complaint of fraud against the by giving them a false name. So when Vanit asked Soham, Soham said that he would return her money and gave her a cheque of Rs 35 lakh. When Vanit paid the cheque, the cheque bounced. So Vanit has filed a complaint of fraud of Rs 35 lakh against Soham at Chandkheda police station.

investigation has cleared the alcohol in the morning and air around rumours of two men dying after allegedly consuming hooch in Dholera.
